<b>Description of the competition procedure</b>	<p>- Proposed candidates to deliver a lecture in which the candidates present their most significant previous professional results and their academic career development plan.</p> <p>- Candidates who do not have at least the teaching degree of lecturer/head of works (obtained following a tenure competition) or candidates who do not come from the higher education system, will additionally deliver a lecture (course) whose topic will be established by the Competition Committee from the topic corresponding to the position.</p>
<b>List of documents</b>	<p>In order to register for the competition for a teaching and research position, the candidate prepares a file, in printed format, which contains at least the following documents:</p> <p>a) the application for registration for the competition signed by the candidate</p>

	<p>and the committee's resolution regarding the information in the standard compliance verification chart (with the members' signatures);</p> <p>b) a proposal for the development of the university career regarding scientific activities and teaching skills, for candidates for teaching positions and, respectively, scientific activities and research skills, for candidates for research positions; the proposal is written by the candidate, comprises of maximum of 10 pages and is one of the main criteria for judging candidates;</p> <p>c) candidate's curriculum vitae in printed and electronic format (Europass model);</p> <p>d) list of the candidate's works in printed and electronic format;</p> <p>e) the verification chart for meeting the university standards, the standard format which is provided by this methodology (Annex 3), in printed and electronic format. The standards of "Valahia" University in Târgoviște cannot derogate from the national minimum standards approved according to art 156 paragraph (1) letter a) and paragraph (2) from the Higher Education Law no 199/2023, with the subsequent amendments and additions. The verification chart is filled in and signed by the candidate;</p> <p>f) documents relating to the possession of a doctoral degree/proof of enrolment in a doctoral study programme, without exceeding the maximum period of study, which includes extensions admissible according to law: copy of the doctoral degree and, if the original doctoral degree is not recognised in Romania, the copy of the certificate of recognition or equivalence thereof;</p> <p>g) the summary in Romanian and in an internationally spoken language of the doctoral thesis, of maximum one page for each language;</p> <p>h) statutory declaration of the candidate indicating the incompatibility situations provided for by the Higher Education Law no 199/2023, with the subsequent amendments and additions, in which they would be in case of winning the competition or the absence of these incompatibility situations;</p> <p>i) copies of other diplomas attesting to the candidate's studies;</p> <p>j) copy of the identity card or, if the candidate does not have an identity card, of the passport or of another identity document drawn up for a purpose equivalent to the identity card or passport;</p> <p>k) if the candidate has changed their name, copies of documents attesting to the name change, namely the marriage certificate or proof of the name change;</p> <p>l) a maximum of 10 publications, patents or other works of the candidate, in electronic format, selected by them and considered to be the most relevant to their professional achievements;</p> <p>m) for candidates for the position of associate professor/scientific researcher level II, respectively university professor/scientific researcher level I: 3 letters of recommendations, in compliance with art 13 from Government Decision 1339/2023;</p> <p>n) criminal record certificate;</p> <p>o) certificate of behavioural integrity;</p> <p>p) medical certificate, issued on a specific form adopted by joint order of the Minister of Education and the Minister of Health;</p> <p>q) medical certificate for practicing the teaching profession, issued according to the provisions of the joint order of the Minister of Education and the Minister of Health;</p> <p>r) copy of the qualification certificate/order regarding the granting of the doctoral supervisor status;</p> <p>s) copy of certificate/attestation of the Psycho-pedagogical module.</p> <p>All copies will be certified as "certified true copy" by the Legal Office.
